Delivery: To address specified by the lessee / renter (customer). Lessee grants right to enter said property for the delivery and pick-up of equipment at approximately specified times.

This is a contract of RENTING only, and not of sale. The undersigned lessee / renter agrees that he / she has rented the item(s) herein described upon the express condition that it will at all times remain the property of the Leasing Company named above.

I, the lessee / renter, have examined the equipment, found it to be in good condition, and will make sure that it is in the same good condition when I am through with my rental of said equipment. I, the lessee / renter, agree to pay, when due, all charges which accrue as a result of this rental, including rental fees and any fees that arise as a result of the repair or replacement of the rented equipment due to damages to the equipment while in my possession.

In the event that I, the lessee / renter, fail to return said item at the agreed upon time, or fail to abide by any of the other terms of this contract, I fully understand that the Leasing Company listed above has the right to repossess it without notice to the me.

All charges / rental fees are based upon the time that the rented item(s) are in my possession, whether in use or not.

I, the lessee / renter, agree to supervise both the equipment and its use at all times in which said equipment is in my possession. Accompanying this contract, or printed on the Safety Label on the unit itself, is a set of directions for use and safety rules, which I agree to follow and utilize at all times during the operation and use of all equipment that I am renting from the above named Leasing Company.

I understand and acknowledge that the activity to be engaged in through my rental of the aforementioned inflatable play structure / ride, brings with it both known and unanticipated risks to myself and my guests and / or invitees. Those risks include, but are not limited to falling, slipping, crashing and colliding, and could result in injury, illness, emotional distress, death, and / or property damage to myself or my guests and invitees.

I voluntarily release, indemnify, hold harmless and discharge the Leasing Company (listed above) from all liability, claims, demands, actions, or rights of actions, whether personal to me or to a third party which are related to, arise out of, or are in any way connected with my rental of the inflatable, including those allegedly attributable to negligent acts or omissions. I agree to reimburse any reasonable attorneys fees and costs which may be incurred by the leasing company (listed above) that I am renting from in the defense of any such liability claim, demand, action or right of action.

In the event that I file a lawsuit against the above named Leasing Company I agree that the substantive law of the state in which the above named Leasing Company presides shall apply in that action without regard to the conflict of law of that state.

I acknowledge that I have adequate homeowner's insurance, tenant insurance, and / or other liability insurance to cover any bodily injury or property damage, which might occur to my guests, my invitees, or myself from the rental and use of the aforementioned inflatable / equipment.

#### SAFETY RULES

Only compatible age groups and sizes shall play on the inflatable at the same time. The following are guidelines as to the number of riders that may be on the inflatable bouncer at the same time:

<b>CHILDREN UP TO AGE 7:</b>	<b>8 – 10</b>
<b>CHILDREN AGES 8 – 12:</b>	<b>5 – 7</b>
<b>INDIVIDUALS OVER 12:</b>	<b>3 – 4</b>

All riders **MUST REMOVE SHOES** before playing in or on the inflatable.

To avoid neck and back injuries, **FLIPS ARE NOT ALLOWED.**

The safety of the children depends on you. Your personal supervision is absolutely required. As the lessee of this inflatable unit, the safety of all the riders is your responsibility.

Absolutely no Silly String, gum, candy, food, or other sticky substances are allowed in or on the inflatable unit. If upon pick-up of the unit, cleaning is necessary due to the presence of such substances, a \$50.00 cleaning fee will be imposed.

Do not remove the inflatable from the area where it was installed. If the inflatable unit moves, pull it by one of it's corners back to its original location of installation. Keep the inflatable unit away from swimming pools.

Should the unit begin to deflate, do the following: First, if the motor has stopped, make sure that it has not been unplugged. If the motor is still running, check the air intake on the side of the motor for blockage, and check both blower tubes on the inflatable unit to make sure that they are tightly tied off.

No alteration in or attachments to the inflatable unit are allowed, period.

Lessee agrees to keep the inflatable unit in his/her possession at all times. Lessee is, under no circumstances, allowed to sublease, rent, sell, remove from the delivery address, or otherwise transfer the inflatable unit. The inflatable unit will remain the property of the lessor and may be removed by lessor at any time after the termination of this rental agreement.

Weather Policy: During periods of severe weather conditions (heavy rain or high winds), we reserve the right to cancel your reservations and give you a full refund of any funds paid to us. If conditions are not too severe, you will have the option of keeping or canceling your reservations. If you decide to keep the reservation, there will be no refunds, discounts, or rain checks.

I, the lessee, acknowledge that I have been instructed about and fully understand how to safely operate the inflatable unit that I have rented. I agree to observe all safety precautions. I also represent and warrant the safe return of the unit and hereby agree to pay \$4,000.00 to the lessor if it is not returned.

I acknowledge and certify, with my signature below, that I have had sufficient opportunity to thoroughly read this document, that I understand its content and that I execute it freely, intelligently, and without duress of any kind, and agree to be bound by its terms.

Any unit involving physical contact requires participant to wear head protection at all times. ***If participant can not securely fasten head protection, participant may not participate on the unit.*** Safety mats must be used at all times on units requiring their use.

1. A Warning Sign with the following copy is attached and made part of each inflatable. All rules should be followed for rider's safety.
  - Do not use the ride unless adult (16+) attendant is present.
  - All riders must remove shoes, eyeglasses, and any other hard or sharp objects that can cause injury.

- No flips, wrestling, running, or pushing.
- Do not bounce against the sides, near the entrance, or on the slide area (if the ride is a slide).
- No food, drinks, gum, pets, or silly strings and no hanging on the unit.
- Exit if ride begins to lose air. Use exit doors and escape hatches provided on roof of covered units.
- Do not use and immediately deflate the ride if winds exceed 15 mph.
- The blower requires a ground fault protected circuit (GFCI).
- Only compatible age groups and size shall use the ride at the same time.

### ADDITIONAL SAFETY RULES

2. No riders should be allowed on a partially inflated unit.
3. Maximum number of riders of each group that should play in the unit at one time is:  
 Castle slide: 6-8 kids eight and under  
 15x15 moonwalk: 8-10 kids eight and under or 6-8 kids 10 and over  
 Combo units: 8-10 kids eight and under or 6-8 kids 10 and over  
 Interactive units: 2 participants and operator  
 18' Slide: 4 participants and one operator on slide  
 Obstacle courses: 2 participants
4. Under no circumstances is climbing on the exterior of the inflatable allowed.
5. Adult supervision is required at all times while the inflatable is in use.
6. Caution should be exercised when lifting and handling the equipment. (A medium size jump unit weighs around 200 lbs.)
7. All extension cords and straps should be placed in such a manner that no one can trip on them. Also, no electrical cords should run through puddles or near a pool.
8. Do not install inflatables near a pool.
9. Never remove the ground pin from the cord. Use an adapter.
10. All inflatables should be securely anchored and fully inflated before any riders are allowed to jump.
11. The blanket should be used on all slides at all times.

### **EMERGENCY EVACUATION PROCEDURE**

The Attendant, before operating the ride, must familiarize himself with the ride's entrance/exit as well as escape hatches. In the unforeseeable event that power is interrupted and the ride begins to lose air, the Attendant should guide all the riders to calmly and orderly leave the ride via the entrance/exit.

All rides that have permanent roofs feature Escape Hatches on the roof. The Attendant may choose to have the riders exit the ride through these easily accessible escape hatches. All rides that have convertible roofs offer the Attendant the alternative of allowing the riders to exit the ride through the wide openings around the roof.
